1. REPLACEMENT OF AUDITOR

The Responsible Entity advises that Deloitte Touche Tohmatsu has resigned as auditor of the Trust in accordance with section 331AC(1) of the *Corporations Act*. ASIC has consented to the resignation. The Responsible Entity has appointed SW Audit as the Trust's new auditor with effect from 12 June 2026.

2. REPLACEMENT OF COMPLIANCE PLAN AUDITOR

The Responsible Entity also advises that Deloitte Touche Tohmatsu has resigned as the compliance plan auditor of the Trust. The Responsible Entity has appointed SW Audit as the Trust's new compliance plan auditor in accordance with section 601HH of the *Corporations Act*, with effect from 12 June 2026.

3. REASON FOR CHANGES

The changes have been made following a tender process. It was determined by the Responsible Entity that the appointment of SW Audit as the auditor of the Trust and the Trust's compliance plan to be in the best interests of the Trust.

The Responsible Entity confirms that there were no disagreements with Deloitte Touche Tohmatsu on audit, accounting, or compliance matters that, if not resolved, would have caused Deloitte Touche Tohmatsu to modify its audit opinions.
